

Moorestown Quakes Hockey Club, Inc.
Parent/Player/Club Agreement
Fall/Winter 2011/2012



This agreement constitutes a binding agreement under the laws of the State of New Jersey between _____ (“Player”) as well as jointly or severally by Player’s parent(s) or legal guardian _____ (“Parent”), and the Moorestown Quakes Hockey Club, Inc. (“Club”), a non-profit youth organization registered with USA Hockey for the 2011/2012 Fall/Winter hockey season, from contract signing date to the conclusion of the Fall/Winter 2011/2012 Playoffs (“season”).

1. The **Club** shall secure registration with SJHSHL and ice time with rinks where practices and games will be held during the season.
2. The **Club** shall secure team practice slots.
3. The **Club** will secure coaching for each team.
4. The **Club** will communicate all pertinent team information via the Club website www.moorestownquakes.com as well as through team managers via email.
5. The **Club** will order jersey(s) and socks upon player request.
6. The **Parent and Player** agree to read, understand and abide by the Club By-Laws and Operating Rules posted on the Club website www.moorestownquakes.com.
7. The **Parent and Player** agree to abide by all the rules and regulations of USA Hockey Inc., SJHSHL, the Flyers Skate Zone and/or The Igloo.
8. The **Parent and Player** acknowledge that failure to abide by the rules set forth in this agreement and the Club Operating Rules and By-Laws will be cause for disciplinary action up to and including dismissal, without refund, from the Moorestown Quakes Hockey Club Inc.
9. The **Parent and Player** agree to read website and Club emails for all pertinent team information on a regular basis.
10. The **Parent and Player** will immediately report to the team head coach any injuries or medical conditions from which the Player suffers.
11. The **Parent and Player** acknowledge that ice hockey is a contact sport. The Parent and Player agree that neither the Moorestown Quakes Hockey Club Inc., nor any of its officers, agents, servants, employees and sponsors shall be held liable for any injury or damage resulting directly or indirectly from and participation with the Club, whether such participation occurs on or off the ice. The Parent and Player further agree that they hereby discharge the organization, its officers, agents, servants, employees and sponsors from any and all actions, claims and demands for injury or damage. It is understood that said release and discharge shall bind the heirs, legal representatives, successors, and assigns of the parties to this agreement. It is further

agreed the Moorestown Quakes Hockey Club Inc. shall not be considered a guarantor of the safety of any equipment or facility provided for the benefit of both Parent and Player.

12. The **Parent and Player** agree that the Club reserves the right to use any pictures taken during Club activities for promotional or instructional purposes without compensation to either Parent or Player. _____ Agree _____ Do Not Agree (Check One)
13. The **Parent and Player** acknowledge and agree that failure to pay the full fees in accordance with the Club's Payment Schedule may result in Player's suspension from all Club activities and/or discharge from the Club without recompense. Any other payment arrangement must be in writing and approved by the Moorestown Quakes Hockey Club Inc. Board.
14. The **Parent and Player** acknowledge and agree that the full fees must be paid, even should the Parent or Player determine to voluntarily leave the Club or the Player be discharged from the Club, subject to the Club's current refund policy.
15. The **Player** agrees to attend all practices and games throughout the season., except when prevented from doing so for educational obligations or medical reasons, in which case, the Player will request permission, **in advance**, to be absent, when reasonably possible. The Moorestown Quakes Hockey Inc. Club acknowledges that such permission will be granted for all reasonable requests.
16. The **Player** will wear all required protective equipment at all times when participating in on-ice activities.
17. The **Parent** will make certain that the Player is in good physical health prior to their participation in Club activities.
18. The **Parent** will provide their player with all necessary HECC approved equipment to participate in the game of ice hockey and to make certain the equipment is maintained in good order.
19. The **Parent** shall be obligated to pay the Club fees as established in the Club's Payment Schedule.
